AN ORDINANCE APPROVING A TEXT AMENDMENT TO SECTION 4.1.3, LIGHTING OF THE LAND DEVELOPMENT CODE TO INCLUDE ADDITIONAL FORM DISTRICTS AND HEIGHT MEASUREMENT METHODOLOGY AND BEING IN LOUISIVLLE METRO (CASE NO. 17AMEND1000).

WHEREAS, the Louisville Metro Planning Commission held a public hearing on this amendment on June 29, 2017 and unanimously recommended approval of this amendment as it conforms to the Guidelines of the Comprehensive Plan; and
