APPROPRIATING \$25,500 AN ORDINANCE \$23,500 \$30,000 FROM **NEIGHBORHOOD** DEVELOPMENT FUNDS BY ALLOCATING IN THE FOLLOWING MANNER: \$20,000 FROM DISTRICT 5; AND \$3,500 \$5,000 FROM DISTRICT 4; AND \$500 EACH FROM DISTRICTS 1, 3, 6, 7, 9, 10, 12, AND 25; AND \$250 EACH FROM DISTRICTS 13, 14, 17, AND 24; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO NEIGHBORHOOD HOUSE, INC. FOR PROGRAMMING AND OPERATING EXPENSES ASSOCIATED WITH DREAMERS' ACADEMY 2017. (AS AMENDED). BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$23,500 \$25,500 \$30,000 is hereby appropriated from Neighborhood Development Funds in

the following manner: by allocating \$20,000 from District 5; and \$3,500_\$5,000 from District 4;, and \$500 each from
