BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$5,000 \$9,100 is hereby appropriated from Neighborhood Development Funds in the following

manner: \$3,000 from District 15; and \$1,000 each from Districts 13 and 21; <u>\$500 each from Districts 6, 10, 22, and 25;</u>

\$250 each from Districts 2, 4, 7, 14, 17, and 20; and \$200 each from Districts 1, 3, and 5; through the Office of
Management and Budget, to The YMCA of Greater Louisville for expenses associated with the 25th annual Turf Classic
and the 2018 Together 4 Teens Breakfast fundraisers.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
