**AN ORDINANCE APPROPRIATING \$5,000 \$9,100 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3,000 FROM DISTRICT 15; AND \$1,000 EACH FROM DISTRICTS 13 AND 21; \$500 EACH FROM DISTRICTS 6, 10, 22, AND 25; \$250 EACH FROM DISTRICTS 2, 4, 7, 14, 17, AND 20; AND \$200 EACH FROM DISTRICTS 1, 3, AND 5; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE YMCA OF GREATER LOUISVILLE FOR EXPENSES ASSOCIATED WITH THE 25<sup>TH</sup> ANNUAL TURF CLASSIC AND THE 2018 TOGETHER 4 TEENS BREAKFAST FUNDRAISERS. (AS AMENDED).**

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$5,000 \$9,100 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 from District 15; and \$1,000 each from Districts 13 and 21; \$500 each from Districts 6, 10, 22, and 25;

\$250 each from Districts 2, 4, 7, 14, 17, and 20; and \$200 each from Districts 1, 3, and 5; through the Office of Management and Budget, to The YMCA of Greater Louisville for expenses associated with the 25<sup>th</sup> annual Turf Classic and the 2018 Together 4 Teens Breakfast fundraisers.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
