AN ORDINANCE APPROPRIATING \$\frac{41,20015,70018,200}{1,20015,70018,200}\$ NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$\frac{3}{3},500\$ FROM DISTRICT 15; \$\frac{5}{2},000\$ FROM DISTRICT 21; \$\frac{1}{5},500\$ EACH FROM DISTRICTS 5, 7, 10, 12, 13, 14, AND 25; \$\frac{1}{3},300\$ FROM DISTRICT 1; \$\frac{250}{5}\$ EACH FROM DISTRICTS 2 AND 9; AND \$\frac{200}{5}\$ EACH FROM DISTRICTS 4 AND 6; TO METRO PARKS DEPARTMENT TO FUND THE 2017 LOUISVILLE JACK O'LANTERN SPECTACULAR HELD AT IROQUOIS PARK AND PROVIDE VOUCHERS FOR REDUCED ADMISSION_(AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$11,20015,70018,200 is hereby appropriated from Neighborhood Development Funds in

the following manner: \$3,500 from District 15; \$2,000 from District 21; \$1,500 each from Districts 5, 7, 10, 12, 13, 14, and
25; \$1,300 from District 1; \$250 each from Districts 2 and 9; and \$200 each from Districts 4 and 6; to Metro Parks
Department to fund the 2017 Louisville Jack O'Lantern Spectacular held at Iroquois Park and provide vouchers for
reduced admission.
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of
passage of this Ordinance.
SECTION IV: This Ordinance shall take effect upon its passage and approval.
