AN ORDINANCE APPROPRIATING \$13,2700 \$25,000 FROM NEIGHBORHOOD DEVELOPMENT FUND IN THE FOLLOWING MANNER: \$3,500 EACH FROM DISTRICTS 25 AND 14; \$3,000 FROM DISTRICT 24; \$2,500 FROM DISTRICT 14 15; \$2,000 EACH FROM DISTRICTS 12 AND 26; \$1,500 FROM DISTRICT 15\$1,300 FROM DISTRICT 20; \$1000 EACH FROM DISTRICTS 1, 13 AND 2622; \$800 FROM DISTRICT 2; \$700 FROM DISTRICT 3; \$500 EACH FROM DISTRICTS 7 AND 10; \$250 EACH FROM DISTRICTS 2, 3, 5, 6, AND 9, 16, 17, AND 18; AND \$200 FROM DISTRICT 4; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO SHIRLEY'S WAY, INC. FOR PROGRAM EXPENSES ASSOCIATED WITH SHIRLEY'S WAY FINANCIAL ASSISTANCE PROGRAM (AS AMENDED).

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$13,2700 \$25,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,500 each from Districts 25 and 14; \$3,000 from District 24; \$2,500 from District 1415; \$2,000 each from Districts 12 and 26; \$1,500 from District 15 \$1,300 from District 20; \$1,000 each from Districts 1, 13 and 26 22; \$800 from District 2; \$700 from District 3; \$500 each from Districts 7 and 10; \$250 each from Districts 2, 3, 5, 6, and 9, 16, 17, and 18; and \$200 from District 4; through the Office of Management and Budget, to Shirley's Way, Inc. for program expenses associated with Shirley's Way Financial Assistance Program.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
