(AS AMENDED)

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$6,000 \$7,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,000 each from Districts 7, 4, 12, 16, and 25; and \$500 each from Districts 6, 13, 17 and 22; and \$250 each from Districts 10 and 15; to Louisville Forward - Economic Development for sponsorship of IdeaFestival.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
