BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The amount of \$6,865 is hereby appropriated from District 11 Neighborhood Development Funds,

through the Office of Management and Budget, to South East Associated Ministries, Inc. to provide funds for repairs and

preventive maintenance to its building located at 6500 Six Mile Lane.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public

purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of

passage of this Ordinance.
