TO LOUISVILLE INDEPENDENT BUSINESS ALLIANCE. INC. то PROVIDE FOR EXPENSES SOUTH LOUISVILLE FUNDS RELATED TO BUY LOCAL FAIR ON OCTOBER 8, 2017.

SPONSORED BY: COUNCIL MEMBERS BLACKWELL, BUTLER, FOWLER, AND WELCH

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$6,000 is hereby appropriated from Neighborhood Development Funds in the following

manner: \$1,500 each from Districts 13, 12, 14 and 15; through the Office of Management and Budget, to

Louisville Independent Business Alliance, Inc. to reimburse funds spent on the South Louisville Buy

Local Fair, which was held on October 8, 2017, including advertising/design, printing, and distribution

for billboards and posters advertising the event; bus and venue rental; event insurance; and event

volunteer related compensation.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended
