BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$12,500~~ \$14,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,000 each from Districts 6, 2, and 5; \$5,000 from District 3; \$750 each

from Districts 1 and 4; and \$500 each from Districts 7, 9, 10, 12, 13, 15, 21, 25 and 26; through the Office of Management and Budget, to University of Louisville Research Foundation, Inc. for costs associated with the “Future of Our Community” forum series.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
