BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The amount of \$5,410 is hereby appropriated from District 15 Neighborhood Development Funds, through the Office of Management and Budget, to Saint Joseph's Area Association, Inc. for beautification of several traffic islands.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
