WHEREAS, the Louisville Metro Planning Commission, as set forth in its minutes and records

of Case No. 17STREETS1010, has recommended to the Legislative Council of the

Louisville/Jefferson County Metro Government (the "Council") that a portion of Derby Avenue north of

Derby Avenue and Granvil Drive be closed because the closing complies with the Land Development

Code; and

WHEREAS, the Council concurs in and adopts the findings of the Planning Commission in

Case No. 17STREETS1010 and approves and accepts the recommendation of the Planning

Commission as set out in said minutes and records.

NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE

#### LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

**SECTION I:** That a portion of Derby Avenue north of Derby Avenue and Granvil Drive and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 17STREETS1010 and as shown on the attached minor subdivision plat, be closed subject to all existing easements of record and all existing utility easements or rights enjoyed by said utility companies as the result of being located in, on or over said right-of-way.

**SECTION II:** This Ordinance shall take effect upon its passage and approval.
