BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: Part I., A. Mayor's Office/Louisville Metro Council, 2. Louisville Metro Council, of Ordinance No. 114, Series 2017, is hereby amended as follows:

LOUISVILLE METRO COUNCIL

a. General Operations General Fund 5,561,300 5,573,300

b. Neighborhood Development Fund General Fund 2.710,000 2.698,000

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This Ordinance shall take effect upon its passage and approval.
