BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$4,500 \$7,250 is hereby appropriated from Neighborhood Development Funds in the following

manner: \$1,500 from District 15; \$1,000 each from Districts 13 and 21; and \$500 each from Districts 9, 10, 12, 14, and

25; \$350 from District 6; and \$300 each from Districts 2, 4, and 5; through the Office of Management and Budget, to The
Food Literacy Project at Oxmoor Farm, Inc. for expenses associated with implementing its Field-to-Fork Program at
Iroquois Urban Farm.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
