AN ORDINANCE AMENDING ORDINANCE NO. 114, SERIES 2017, RELATING TO THE FISCAL YEAR 2017-18 OPERATING BUDGET FOR LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT, BY TRANSFERRING \$25,000 FROM THE NEIGHBORHOOD DEVELOPMENT FUND (DISTRICT 21) TO LOUISVILLE METRO COUNCIL GENERAL OPERATIONS (DISTRICT 21).

WHEREAS, the Louisville Metro Council District 21 seat is currently vacant, and

WHEREAS, the Louisville Metro Council District 21 general operation budget was woefully mismanaged, currently being negative, and

WHEREAS, the President of the Council seeks to ensure the continued operations of the District 21 office.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: Part I., A. Mayor's Office/Louisville Metro Council, 2. Louisville Metro Council, of Ordinance No. 114, Series 2017, is hereby amended as follows:

2. LOUISVILLE METRO COUNCIL

- a. General Operations General Fund ~~5,561,300~~ 5,586,300
- b. Neighborhood Development Fund General Fund ~~2,710,000~~ 2,685,000

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This Ordinance shall take effect upon its passage and approval.
