**WHEREAS**, the Louisville/Jefferson County Metro Government wishes to enter into this agreement through the Department of Public Works & Assets.

**BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept \$2,180,000 of funding for the construction phase for the West End Paving Project. Rehabilitation will include portions of Muhammad Ali Boulevard, River Park Drive, Chestnut Street, Market Street and 16<sup>th</sup> Street.

**SECTION II:** This Resolution shall take effect upon its passage and approval.
