BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY **METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

SECTION I: The Mayor is hereby authorized to enter into an agreement with the Commonwealth of

Kentucky Transportation Cabinet to accept \$733,000 of funding for the construction phase of

sidewalk improvements along Hill Street between 6th and 7th Streets.
