NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

SECTION I: That the zoning of the property located at 1014 and 1016 Franklin Street containing 8,276 square feet and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 17ZONE1037, is hereby changed from R-6 Residential Multi-Family to CM Commercial Manufacturing; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 17ZONE1037.

SECTION II: This Ordinance shall take effect upon its passage and approval.
