BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The amount of \$12,279 is hereby appropriated from District 23 Neighborhood Development Funds, through the Office of Management and Budget, to the Jefferson County Public Education Foundation, Inc. for the installation of playground equipment, which will benefit the school and the surrounding community, at Wilt Elementary School.
