WHEREAS, the Metro Government wishes to enter into this agreement through the Metro Parks Department of Public Works and Assets.

BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept additional funding of \$149,975 for the continued design phase of the Pond Creek section of the Louisville Loop at the Jefferson Memorial Forest.

SECTION II: This Resolution shall take effect upon its passage and approval.
