A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT \$543,947 OF ADDITIONAL FUNDING FROM THE COMMONWEALTH OF KENTUCKY TRANSPORTATION CABINET FOR THE LOUISVILLE LOOP JEFFERSON MEMORIAL FOREST MEDORA PROJECT TO BE ADMINISTERED BY THE METRO PARKS DEPARTMENT OF PUBLIC WORKS AND ASSETS. (AS AMENDED)

WHEREAS, the Metro Government wishes to enter into this agreement through the Metro Parks Department of Public Works and Assets.

BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept additional funding of \$543,947 for the continued design phase and right of way phase of the Medora section of the Louisville Loop at the Jefferson Memorial Forest.

SECTION II: This Resolution shall take effect upon its passage and approval.
