**SECTION I:** The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept additional funding of \$136,364 for the right-of-way phase of the Louisville Loop section along Shelbyville Road between Beckley Woods and Beckley Station Road.
