A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT \$67,666.23 OF FUNDING FROM THE KENTUCKIANA REGIONAL PLANNING & DEVELOPMENT AGENCY FOR THE ACQUISITION AND INSTALLATION OF THREE OUTDOOR WARNING SIRENS AND RELATED EQUIPMENT TO BE ADMINISTERED BY THE DEPARTMENT OF EMERGENCY SERVICES.

WHEREAS, the Metro Government wishes to enter into this agreement through the Department of Emergency Services.

SECTION I: The Mayor is hereby authorized to enter into an agreement with the Kentuckiana Regional Planning & Development Agency to accept \$67,666.23 of funding for the acquisition and installation of three outdoor warning sirens and related equipment.
