AN ORDINANCE APPROPRIATING **\$7,800**\$9,800 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3,000 FROM DISTRICT 15; \$2,000 FROM DISTRICT 21; \$1,000 EACH FROM DISTRICTS 13, 14, AND 25; \$500 EACH FROM DISTRICTS 1, 10, AND 12; AND \$300 FROM DISTRICT 6; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET. TO THE SOUTH LOUISVILLE COMMUNITY MINISTRIES, INC. (SLCM) FOR **EXPENSES** ASSOCIATED WITH CONDUCTING THE SLCM GOLF SCRAMBLE AND "FAMILIES FAMILIES" FUNDRAISING PROJECTS SUPPORT HELPING AND TO THEIR EMERGENCY ASSISTANCE PROGRAM. (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$7,800<u>\$9,800</u> is hereby appropriated from Neighborhood Development

Funds in the following manner: \$3,000 from District 15; \$2,000 from District 21; \$1,000 each from

Districts 13, <u>14</u>, and 25; \$500 <u>each</u> from Districts <u>1</u>, <u>10</u>, <u>and</u> <u>12</u>; and \$300 from District 6; through the Office of Management and Budget, to the South Louisville Community Ministries, Inc. (SLCM) for expenses associated with conducting the SLCM golf scramble and "Families Helping Families" fundraising projects and to support their emergency assistance program.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective

at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
