BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:
SECTION I: The sum of \$16,950 \$17,500 \$21,000 is hereby appropriated from Neighborhood
Development Funds in the following manner: \$8,000 from District 14; \$2,000 from District 9; \$1,000
each from Districts 1, 12, 13, 15, and 25; \$500 each from Districts <u>4,</u> 6, 7, and 10 <u>, 11, 21, 24, and 26</u>
\$300 each from Districts 17 and 22; \$250 each from Districts 3, 5, 20 and District 8; and \$200 each
from Districts 16 and 23; through the Office of Management and Budget, to Louisville Asset Building
Coalition, Inc. for operating expenses associated with coordinating the Volunteer Income Tax
Assistance Program (VITA).
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for
a public purpose.
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective
at the date of passage of this Ordinance.
SECTION IV: This Ordinance shall take effect upon its passage and approval.
