AN ORDINANCE ADOPTING THE SOUTH DIXIE HIGHWAY MASTER PLAN AND ITS EXECUTIVE SUMMARY AS AMENDMENTS TO THE CORNERSTONE 2020 COMPREHENSIVE PLAN (CASE NOS. 18NEIGHPLAN1000 & 18NEIGHPLAN1001). SPONSORED BY: COUNCILWOMAN MADONNA FLOOD

WHEREAS, the Louisville Metro Planning Commission held a public hearing on March 29,

2018 on approving the South Dixie Highway Master Plan and approving amendments to the

Cornerstone 2020 Comprehensive Plan to incorporate the Plan's Executive Summary in cases

18NEIGHPLAN1000 and 18NEIGHPLAN1001; and

WHEREAS, the Planning Commission found that the South Dixie Highway Master Plan

conforms to the adopted Guidelines and Policies of the Cornerstone 2020 Comprehensive Plan and

the incorporation of the South Dixie Highway Master Plan's Executive Summary into Cornerstone

2020 also conforms to the adopted Guidelines and Policies of the Cornerstone 2020 Comprehensive Plan; and

WHEREAS, the Legislative Council of the Louisville/Jefferson County Metro Government (the "Council") has considered the evidence presented at the public hearing held by the Louisville Metro Planning Commission and the recommendations of the Commission and its staff as set out in the minutes and records of the Planning Commission in Case Nos. 18NEIGHPLAN1000 and 18NEIGHPLAN1001; and

WHEREAS, the Council concurs in and adopts the findings and recommendations of the Planning Commission approving the South Dixie Highway Master Plan and approving amendments to Cornerstone 2020 to incorporate the Executive Summary of the South Dixie Highway Master Plan in Case Nos. 18NEIGHPLAN1000 and 18NEIGHPLAN1001, and approves and accepts the recommendations of the Planning Commission as set out in said minutes and records.

NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

SECTION I: That the South Dixie Highway Master Plan included in the records of the Planning Commission in Case Nos. 18NEIGHPLAN1000 and 18NEIGHPLAN1001 is hereby adopted.

SECTION II: The Executive Summary of the South Dixie Highway Master Plan included in the minutes and records of the Planning Commission in Case Nos. 18NEIGHPLAN1000 and 18NEIGHPLAN1001 is hereby adopted as amendments to the Cornerstone 2020 Comprehensive Plan.

SECTION III: This Ordinance shall take effect upon its passage and approval.
