BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The Mayor is hereby authorized to accept \$290,000 from the Kentucky Transportation Cabinet for the planning phase of the Central Business District Traffic Model Project. The project involves development of a travel demand model and evaluation of roadway reconfigurations and safety/capacity improvements of the Louisville urban core.
