A RESOLUTION DETERMINING A PARCEL OF REAL PROPERTY, LOCATED **OF** 6217 COOPER CHAPEL ROAD, LOUISVILLE, KENTUCKY, A DESCRIPTION OUT WHICH IS SET **EXHIBIT** ATTACHED HERETO, BY LOUISVILLE/JEFFERSON COUNTY **METRO** GOVERNMENT ("METRO GOVERNMENT") AS **SURPLUS** AND **NEEDED** NOT FOR Α GOVERNMENTAL PURPOSE AND **AUTHORIZING** ITS TRANSFER TO HENRY FORD. JR. \$500.00.

WHEREAS, according to KRS Chapter 67C.101, Metro Government may sell or transfer any real property belonging to Metro Government; and

WHEREAS, Section 1(A) of Executive Order No. 2, Series 2011 of the Mayor, which adopts Section 2(C) of Executive Order No. 3, Series 2007, provides that Metro Government may convey surplus real estate upon declaration by the Legislative Council of Metro Government ("the Council") that such property is no longer needed for the governmental purposes of Metro Government; and

WHEREAS, the parcel of real property which is the subject of this Resolution is vacant unimproved property presently owned by Metro Government; and

WHEREAS, the Director of Louisville/Jefferson County Metro Government, Public Works Department has declared and certified to the Metro Council that the real property which is the subject of this Resolution is surplus to the needs of Metro Government (see Exhibit A attached hereto and made a part hereof); and

WHEREAS, Metro Government wishes to sell the real property which is the subject of this Resolution to Henry Ford, Jr. for \$500.00 subject to and in accordance with the terms and provisions of the Application to Purchase Property, a copy of which is attached hereto as Exhibit B.

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("COUNCIL") AS FOLLOWS:

SECTION I: The Council hereby declares the real property described in Exhibit A attached hereto as "SURPLUS" and determines that it is not needed to carry out the governmental functions of Metro Government.

SECTION II: The Mayor is hereby authorized to transfer the property named herein to Henry Ford, Jr. for the purchase price of \$500.00 in the manner provided according to Section 2 of Executive Order No. 3, Series 2007, without further action by the Council.

SECTION III: This Resolution shall take effect upon its passage and approval.
