SECTION I: The sum of \$9,700 \$13,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,500 \$5,000 from District 4; \$1,500 \$1,550 from District 3; \$1,000each from Districts 1 and 20; \$750 from District 6; \$500 each from Districts 5, 21, and 22; \$250 each from Districts 2, 9, 10, 13, 15, 17, 24, and 26; and \$200 from District 7; through the Office of Management and Budget, to Sowing Seeds With Faith Inc. for costs associated with the Sowing Seeds with Faith Academic Enrichment Summer Camp.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
