**ORDINANCE NO. \_\_\_\_\_, SERIES 2018**  
**AN ORDINANCE CLOSING PORTIONS OF OLD 18<sup>TH</sup> STREET AND OLD DIXIE HIGHWAY AND BEING IN LOUISVILLE METRO (CASE NO. 17STREETS1027).**  
**SPONSORED BY: COUNCILWOMAN MADONNA FLOOD**

**WHEREAS**, the Louisville Metro Planning Commission, as set forth in its minutes and records of Case No. 17STREETS1027, has recommended to the Legislative Council of the Louisville/Jefferson County Metro Government (the “Council”) that portions of Old 18<sup>th</sup> Street and Old Dixie Highway be closed; and

**WHEREAS**, the Council concurs in and adopts the findings of the Planning Commission in Case No. 17STREETS1027 and approves and accepts the recommendations of the Planning Commission as set out in said minutes and records.

**NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (“COUNCIL”) AS FOLLOWS:**

**SECTION I:** That portions of Old 18th Street and Old Dixie Highway and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 17STREETS1027 and as shown on the attached street closure plats, be closed, subject to all existing utility easements or rights enjoyed by said utility companies as the result of being located in, on, or over said right-of-way.

**SECTION II:** This Ordinance shall take effect upon its passage and approval.
