BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$12,500 is hereby appropriated from District 6 Neighborhood

Development Funds, to Metro Parks Department for Metro Park Events in District 6 to include "Jazz

in Central Park," "California Day," Parkhill Interactive Video Games, and Winter Holiday Events.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for

a public purpose.
