AN ORDINANCE AMENDING LMCO § 32.730(A)(1) TO INCLUDE THE PRESIDENT OF THE FRATERNAL ORDER OF POLICE LODGE 77 LOUISVILLE METRO CORRECTIONS AND THE PRESIDENT OF RIVER CITY FRATERNAL ORDER OF POLICE LODGE 614.

WHEREAS, The Louisville Metro Criminal Justice Commission exists in part to evaluate the capacity of criminal justice and public safety agencies through a careful study of existing laws, practices, and institutions, to recognize their areas of strength and weakness, and to formulate proposals to maintain the former and correct the later; and,

WHEREAS, the Fraternal Order of Police Lodge 77 Louisville Metro Corrections and the River City Fraternal Order of Police Lodge 614 are vital stakeholders within the Louisville Metro Criminal Justice system.

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The Council hereby amends LMCO § 32.730(A)(1) to read as follows:

(A) (1) The Louisville Metro Criminal Justice Commission shall be composed of ~~27~~ 29 members. The membership of the Commission shall include the following who shall serve by virtue of office or position or their designated representative from their respective office:

Director, Kentucky Probation and Parole

Director, Office of Pre-Trial Services for Jefferson County

Chief Public Defender/Executive Director, Louisville/ Jefferson County Public Defender Corporation

Executive Director, Louisville Bar Association

Director, Restorative Justice Louisville

President of Metro Council

Director, Louisville Metro Youth Detention Services

Director, Safe Neighborhoods

Director, ~~Seven Counties Services~~ Centerstone, Inc.

Jefferson Circuit Court Clerk

Jefferson County Sheriff

Jefferson Trial Courts Chief Court Administrator
