BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$6,750 is hereby appropriated from Neighborhood Development Funds, in the following manner:

\$1,500 from District 5; \$1,000 each from Districts 1, 2, and 3; \$500 each from Districts 6, 7, and 26; and \$250 each from

Districts 10, 14, and 15; through the Office of Management and Budget, to Louisville Metro Police Foundation, Inc. for

programming costs associated with the West Louisville Appreciation Festival.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
