AN ORDINANCE AMENDING ORDINANCE NO. 108, SERIES 2018 AS PERTAINING TO THE FISCAL YEAR 2018-2019 OPERATING BUDGET BY AMENDING THE LANGUAGE RELATED TO THE \$60,000 GRANT TO THE URBAN LEAGUE FOR HOUSING REHABILITATION TO JESUS & A JOB GROUP TO BE ADMINISTERED BY THE OFFICE FOR SAFE & HEALTHY NEIGHBORHOODS.

SPONSORED BY: COUNCIL PRESIDENT JAMES AND COUNCIL MEMBER HAMILTON

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: Part I., F. Chief of Community Building, of Ordinance No. 108, Series 2018, is hereby amended as follows:

5. OFFICE FOR SAFE AND HEALTHY NEIGHBORHOODS

a. General Operations

(1) General Fund 2,577,400

(2) Agency and Other Receipts <u>1,100,000</u>

Included in F.5.a.(1) above is \$892,600 for Sites 1 and 2 of No More Red Dots Violence Reduction Program, \$446,200 for Site 3 at U of L Hospital/Peace Education and \$446,200 for Site 4 at YMCA, \$15,000 grant to Urban League for Expungement Program, \$15,000 grant to Board 4 Change, \$60,000 grant to Urban League Jesus & A Job Group for Housing Rehabilitation and \$25,000 grant to Life Hope Center for Peace Basketball League.

SECTION II: The Council has determined the funds requested in this ordinance will be expended for a public purpose.
