ORDINANCE NO. , SERIES 2018

AN ORDINANCE APPROPRIATING **\$21,500**\$30,000 FROM **NEIGHBORHOOD** DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$14,000 FROM DISTRICT 3; \$10,000 FROM DISTRICTS 2 AND 3; \$1,250 FROM DISTRICT 21; \$1,000 FROM DISTRICTS 1 AND 4; AND \$500 FROM DISTRICTS 6 AND 15; AND \$250 FROM DISTRICTS 9, 10, 13, 14, 17, 20, AND 24; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE LINCOLN FOUNDATION FOR COSTS ASSOCIATED WITH THE WHITNEY M. YOUNG SCHOLARS PROGRAM (AS AMENDED). COUNCIL MEMBERS SHANKLIN, WOOLRIDGE, LANSHIMA, SPONSORED BY: GREEN, SEXTON SMITH, BUTLER, HOLLANDER, MULVIHILL, WELCH, FOWLER, STUCKEL, BENSON, FLOOD, AND PRESIDENT JAMES

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of <u>\$21,500</u><u>\$30,000</u> is hereby appropriated from Neighborhood Development

Funds in the following manner: <u>\$14,000 from District 3;</u> \$10,000 from Districts 2 and 3; <u>\$1,250 from</u>

District 21; \$1,000 from Districts 1 and 4; and \$500 from Districts 6 and 15; and \$250 from Districts 9,

10, 13, 14, 17, 20, and 24; through the Office of Management and Budget, to the Lincoln Foundation

for costs associated with the Whitney M. Young Scholars Program

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective

at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
