BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$8,300\$10,000 is hereby appropriated from the Neighborhood Development Funds in the following manner: \$5,000 from District 3; \$1,500 from District 5; \$1,000 from Districts 2 and 21; \$500 from District 4, and \$300 from District 1; \$250 from Districts 7 and 17; and \$200 from District 6; through the Office of Management and Budget, to Self-Esteem Inc. for program expenses.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
