FOR PROGRAMMING EXPENSES ASSOCIATED WITH THE JEFFERSON COUNTY HIGH SCHOOL FRESHMAN 10,000 TREE GIVEAWAY (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The total of ~~\$6,250~~~~\$2,500~~~~\$1,000~~ is hereby appropriated from Neighborhood Development Funds in the following manner: ~~\$2,500~~ from District 7; ~~\$1,000~~ from Districts 7 and 9;

\$500 from Districts 8 and 15; \$250 from Districts 10, 12 and 13, 14, 17, 21, and 22; through the Office of Management and Budget, to TreesLouisville, Inc. for programming expenses associated with the Jefferson County High School Freshman 10,000 Tree Giveaway.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
