JOSEPH CATHOLIC ORPHAN SOCIETY DBA ST. JOSEPH CHILDREN'S HOME FOR COSTS ASSOCIATED WITH SECURITY MEASURES FOR THE 169TH ST. JOE'S PICNIC FOR THE KIDS (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY

METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$9,760~~~~\$7,900~~~~\$6,650~~ is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,500 from District 9; ~~\$1,000 from District 7~~; \$800 from District 6; ~~\$610 from District 21~~; \$500 each from Districts ~~7~~, 10, and 15, ~~16~~, and 18; \$300 from District 17; \$250 each from Districts 2, 3, ~~12~~, 13, 14, ~~18~~, 20, 22, 24 and ~~25~~; and \$150 each from Districts 1 and 4; through the Office of Management and Budget, to St. Joseph Catholic Orphan Society dba St. Joseph Children's Home for costs associated with security measures for the 169th St. Joe's Picnic for the Kids.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
