**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$14,550 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,500 from District 15; \$2,000 from District 21; \$1,500 each from Districts 7, 10, 13, and 25; \$1,300 from District 1; \$750 each from Districts 12 and 14; and \$250 from District 6; to Metro Parks Department to fund the 2018 Louisville Jack O'Lantern Spectacular held at Iroquois Park and provide vouchers for reduced admission.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
