FOR PROGRAM EXPENSES ASSOCIATED WITH SHIRLEY'S WAY FINANCIAL ASSISTANCE PROGRAM (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of ~~\$5,001~~ \$8,251 \$12,751 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,501 from District 25; \$2,000 from District 14; \$1,500 from District 26; \$1,000 each from Districts 13 and 15; \$500 each from Districts 1, 3, 6, 10, 12, 13, 17, 20, 22; and \$250 from District 9; through the Office of Management and Budget, to Shirley's Way, Inc. for program expenses associated with Shirley's Way Financial Assistance Program.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
