BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$6,400 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 10; \$500 each from Districts 9, 12, 13, 14, 15, 21, and 24; \$250 each from Districts 1 and 3; \$200 from District 6; and \$100 each from Districts 4 and 7; through the Office of Management and Budget, to Louisville Nature Center, Inc. for expenses associated with hosting its Birds, Brews and BBQ fundraiser.
