BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The amount of \$89,583.20 is hereby appropriated from Neighborhood Development

Funds in the following manner: The amount of \$54,583.20 is hereby appropriated from District 25

and \$35,000 from District 3Neighborhood Development Funds to Louisville Metro Public Works and

Assets to fund the addition of 63 streetlights in District 25 and 30 Streetlights in District 3.
