(C.H.O.I.C.E., INC.), DREAM" EXPERIENCES, FOR THE TO **SPORTS** LEADERSHIP AND MENTORING PROGRAM (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$7,000 \$18,200 is hereby appropriated from District 22 Neighborhood Development Funds, in the following manner: \$11,200 from District 21 and \$7,000 from District 22; through the Office of Management and Budget, to C.H.O.I.C.E., Inc., for the "Dare to Dream" sports leadership and mentoring program.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.
