**AN ORDINANCE APPROPRIATING ~~\$40,000~~ \$29,000 FROM DISTRICT 26 NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$10,000 FROM DISTRICT 26; \$3,000 FROM DISTRICT 3; \$2,500 FROM DISTRICT 8; \$1,500 FROM DISTRICTS 9 AND 21; \$1,000 FROM DISTRICTS 1, 2, 4, 7, 10, 12, 13, 14, 24, AND 25; AND \$500 FROM DISTRICT 6; TO OFFICE FOR WOMEN FOR PROGRAM EXPENSES (AS AMENDED).**

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: The amount of ~~\$40,000~~\$29,000 is hereby appropriated from the District 26 Neighborhood Development Funds in the following manner: \$10,000 from District 26; \$3,000 from District 3; \$2,500 from District 8; \$1,500 from Districts 9 and 21; \$1,000 from Districts 1, 2, 4, 7, 10, 12, 13, 14, 24, and 25; and \$500

from District 6; to the Office for Women for program expenses.

**SECTION II:** A portion of the appropriations are specifically designated to the following projects:

<u>Community Interactive Learning Website about Suffrage History</u> <u>(\$1,000 from District 7; \$1,500 from District 9)</u>	<u>\$2,500</u>
<u>Eviction Diversion Program</u> <u>(\$3,000 from District 3 )</u>	<u>\$3,000</u>
<u>Gen WOW Girls Mentoring Program</u> <u>(\$500 from District 10; \$1,000 from Districts 14 and 25)</u>	<u>\$2,500</u>
<u>Short Changing Women Study</u> <u>(\$2,500 from District 8)</u>	<u>\$2,500</u>

**SECTION III:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III IV:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
