\$10,000 FROM DISTRICT 26, \$3,000 FROM DISTRICT 3; \$2,500 FROM DISTRICT 8; \$1,500 FROM DISTRICTS 9 AND 21; \$1,000 FROM DISTRICTS 1, 2, 4, 7, 10, 12, 13, 14, 24, AND 25; AND \$500 FROM DISTRICT 6; TO OFFICE FOR WOMEN_FOR PROGRAM EXPENSES (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:

SECTION I: The amount of \$10,000\$29,000 is hereby appropriated from the District 26 Neighborhood Development

Funds in the following manner: \$10,000 from District 26; \$3,000 from District 3; \$2,500 from District 8;

\$1,500 from Districts 9 and 21; \$1,000 from Districts 1, 2, 4, 7, 10, 12, 13, 14, 24, and 25; and \$500

from District 6; to the Office for Women for program expenses.

SECTION II: A portion of the appropriations are specifically designated to the following projects:
