AN ORDINANCE APPROPRIATING ~~\$13,000~~ ~~\$22,000~~ \$13,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: ~~\$10,000~~ ~~\$18,000~~ \$8,750 FROM DISTRICT 5; \$2,000 FROM DISTRICT 3; AND \$1,000 each FROM DISTRICTs 4 AND 15; \$250 from district 6 **THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO NEIGHBORHOOD HOUSE FOR EXPENSES ASSOCIATED WITH REPAIRING ITS ROOF AND GUTTERS FACILITIES (AS AMENDED).**

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$13,000~~ ~~\$22,000~~ \$13,000 is hereby appropriated from Neighborhood Development Funds in the following manner: ~~\$10,000~~ ~~\$18,000~~ \$8,750 from District 5 with \$6,000 designated for HVAC repair and \$2,000 designated for painting and wall repair; \$2,000 from District 3; and \$1,000 each from Districts 4 and 15; \$250 from District 6; through the Office of Management and Budget, to Neighborhood House for expenses associated with repairing its roof and gutters facilities.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
