BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$43,000~~ \$22,000 \$13,000 is hereby appropriated from Neighborhood Development Funds in the following manner: ~~\$40,000~~ \$18,000 \$8,750 from District 5 with \$6,000 designated for HVAC repair and \$2,000 designated for painting and wall repair; \$2,000 from District 3; and \$1,000 each from Districts 4 and 15; \$250 from District 6; through the Office of Management and Budget, to Neighborhood House for expenses associated with repairing its roof and gutters facilities.
