AN ORDINANCE APPROPRIATING ~~\$10,000~~\$30,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 EACH FROM DISTRICTS 3, 4 AND, 17, AND 21, \$3,000 FROM DISTRICT 13, \$1,000 EACH FROM DISTRICTS 14, 20, 22, AND 26, AND \$500 EACH FROM DISTRICTS 1, 7, 9, 10, 16, AND 18; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO YOUNG ADULT DEVELOPMENT IN ACTION, INC. (AKA YOUTHBUILD LOUISVILLE) FOR COSTS ASSOCIATED WITH BUILDING A JOB DEVELOPMENT CENTER AS PART OF THE CAPITAL PROJECT, RISE TOGETHER. (AS AMENDED)

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$10,000~~\$30,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 each from Districts 3, 4, and 17, and 21, \$3,000 from District 13, \$1,000 each from Districts 14, 20, 22,

and 26, and \$500 each from Districts 1, 7, 9, 10, 16, and 18; through the Office of Management and Budget, to Young Adult Development in Action, Inc. (AKA YouthBuild Louisville) for costs associated with building a job development center as part of the capital project, Rise Together.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
