ORDINANCE NO, SERIES 2019 AN ORDINANCE CHANGING THE ZONING FROM R-4 RESIDENTIAL SINGLE FAMILY TO C-1 COMMERCIAL AND CM COMMERCIAL MANUFACTURING AND CHANGING THE FORM DISTRICT FROM NEIGHBORHOOD TO SUBURBAN MARKETPLACE CORRIDOR ON PROPERTY LOCATED AT 8319 AND 8323

WHEREAS, the Legislative Council of the Louisville/Jefferson County Metro Government (the

"Council") has considered the evidence presented at the public hearing held by the Louisville Metro

Planning Commission and the recommendations of the Planning Commission and its staff as set out

in the minutes and records of the Planning Commission in Case No. 17ZONE1067; and

WHEREAS, the Council concurs in and adopts the findings of the Planning Commission for

the zoning changes and the form district change in Case No. 17ZONE1067 and approves and

accepts the recommendations of the Planning Commission as set out in said minutes and records;

NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

SECTION I: That the zoning of the property located at 8319 and 8323 Preston Highway containing 28,500.19 square feet and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 17ZONE1067, is hereby changed from R-4 Residential Single Family to C-1 Commercial and CM Commercial Manufacturing and the form district of the aforesaid property is hereby changed from Neighborhood to Suburban Marketplace Corridor; provided, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 17ZONE1067.

SECTION II: This Ordinance shall take effect upon its passage and approval.
