**AN ORDER TO APPROVE A \$10,000 FAITHFUL PERFORMANCE BOND FOR ANDRE THOMAS IN HIS CAPACITY AS CONSTABLE OF JEFFERSON COUNTY, KENTUCKY.**

**WHEREAS**, in accordance with KRS 72.310, the Constable shall execute a bond for the faithful performance of the duties of that office; and

**WHEREAS**, the Legislative Council of the Louisville/Jefferson County Metro Government has determined that a \$10,000 Faithful Performance Bond is sufficient to insure the faithful performance of Andre Thomas in his capacity as Jefferson County Constable.

**NOW, THEREFORE, BE IT ORDERED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("COUNCIL") AS FOLLOWS:**

**SECTION I:** The Council approves the aforesaid bond in the stated amount for Jefferson County Constable Andre Thomas and directs that the bond shall be filed with the Jefferson County Court Clerk.

**SECTION II:** This Order shall take effect upon its passage and approval.
